

A BRIEF SUMMARY
OF THE HISTORY OF
THE LIFE MEMBERS CLUB
A.S.H.R.A.E.

JANUARY, 1964

PREAMBLE:

THE FOLLOWING HISTORY OF THE LIFE MEMBERS CLUB HAS BEEN PREPARED BY WILLIAM M. WALLACE, II, PERMANENT VICE-CHAIRMAN OF THE CLUB. MOST OF THE DATA HAS BEEN EXTRACTED FROM THE MEAGER FILES WHICH ARE AVAILABLE AT THIS TIME AND FROM PERSONAL CONVERSATIONS WITH OUR WORTHY FIRST PERMANENT SECRETARY, MR. E. K. CAMPBELL OF KANSAS CITY, MISSOURI. SOME DATA HAS ALSO BEEN FURNISHED BY OTHER MEMBERS OF THE CLUB.

A LARGE PORTION OF THE CLUB FILES WERE DESTROYED BY A FLOOD WHICH INVADED THE E. K. CAMPBELL COMPANY FACTORY AND OFFICES ABOUT 1961. THIS HAS COMPLICATED THE ASSEMBLY OF ACCURATE DATA.

MR. E. K. CAMPBELL SERVED AS PERMANENT SECRETARY-TREASURER FOR THE CLUB FROM ITS INCEPTION UNTIL HIS DEATH ON NOVEMBER 25, 1962. ALL MEMBERS OF THE LIFE MEMBERS CLUB, AS WELL AS ALL OTHER SOCIETY MEMBERS WHO KNEW AND ADMIRERD MR. CAMPBELL HAVE DEEPLY FELT THIS LOSS.

IN 1920 WHEN MR. CAMPBELL WAS 45 YEARS OF AGE, HE JOINED THE A.S.H.V.E. AT THAT TIME THE REQUIREMENT FOR LIFE MEMBERS WAS TO HAVE PAID DUES FOR 25 YEARS AND TO HAVE REACHED 70 YEARS OF AGE. HE THEREFORE COMPLIED WITH BOTH REQUIREMENTS AT THE SAME TIME IN 1945 AND THUS BECAME A LIFE MEMBER. SHORTLY AFTER THAT THE REQUIREMENTS WERE CHANGED TO 30 YEARS OF PAYING DUES AND TO HAVE ATTAINED THE AGE OF 65 YEARS. THESE ARE THE REQUIREMENTS WHICH ARE NOW IN EFFECT IN THE A.S.H.R.A.E. IN REGARD TO LIFE MEMBERS.

INCEPTION:

ABOUT 1944 OR A LITTLE EARLIER MR. WILLIS H. CARRIER MADE A TALK TO THE KANSAS CITY CHAPTER OF A.S.H.V.E. AT THAT TIME THERE WERE VERY FEW LIFE MEMBERS BUT MR. CARRIER WAS ONE OF THESE FEW. MR. E. K. CAMPBELL WAS PRESENT AS A CHAPTER MEMBER AND WAS PARTICULARLY INTERESTED AND LATER REMEMBERED THE PHASE OF THIS TALK WHEREIN MR. CARRIER COMPARED THE SOCIETY TO A STOKER AND THE MEMBERS TO THE

LUMPS OF COAL WHICH WERE LOADED INTO THE HOPPER, JOGGLED DOWN THROUGH THE HOPPER INTO THE WORM-CONVEYOR, AND PUSHED INTO THE RETORT. WHEN MOST OF THE GOOD FUEL IN THE MEMBER WAS BURNED OUT, LEAVING ONLY A CLINKER, HE WAS DUMPED OUT ON THE CLINKER PILE. THUS HE COMPARED HIMSELF AND OTHER LIFE MEMBERS TO "OLD CLINKERS" WHICH HAD BEEN BURNED OUT AND WERE BEING DISCARDED.

ABOUT 1954 MR. CAMPBELL NOTED THAT THE LIFE MEMBERS WERE LISTED IN THE ROSTER BUT HAD NO SPECIFIC ACTIVITY IN THE SOCIETY. HE ALSO REMEMBERED MR. CARRIER'S COMPARISON OF THE "OLD CLINKERS" AND SUGGESTED TO MR. A. V. HUTCHINSON THAT THE SOCIETY SHOULD ARRANGE A LUNCHEON DURING THE NATIONAL MEETING WHERE THE "OLD CLINKERS" (LIFE MEMBERS) COULD GET TOGETHER, SWAP REMEMBRANCES, RENEW ACQUAINTANCES, AND HAVE A MUCH BETTER TIME THAN THEY WOULD JUST SITTING OFF IN A CORNER BY THEMSELVES. "E. K." HAD ALSO SUGGESTED THAT THE LUNCHEONS BE MADE "DUTCH TREAT" SO THAT IT WOULD NOT COST THE SOCIETY ANYTHING AND WOULD NOT HAVE TO BE APPROVED BY ANY COMMITTEE. UNDER THESE CONDITIONS THESE LUNCHEON MEETINGS WOULD BE STRICTLY "UNOFFICIAL".

IT WAS HURRIEDLY ARRANGED TO HAVE THE FIRST LUNCHEON MEETING OF THE LIFE MEMBERS AT PHILADELPHIA IN 1955. THIS MEETING WAS NOT PROPERLY ANNOUNCED IN THE PROGRAM NOR AT ANY OF THE TECHNICAL SESSIONS AND THE ONLY MEMBER WHO SHOWED UP WAS "E. K." AND THERE WAS NO LUNCHEON. "E. K." REMARKED AT THAT TIME THAT THE "OLD CLINKERS" SEEMED TO BE SO BURNED OUT THAT THEY COULD NOT EVEN GET THEMSELVES TOGETHER FOR A LUNCHEON.

HISTORY:

IN THE FOLLOWING BRIEF SUMMARY MR. CAMPBELL'S PHRASEOLOGY HAS BEEN FOLLOWED WHERE POSSIBLE. MANY OF THE CLUB MEMBERS WILL RECOGNIZE HIS BREVITY AND CONCISE STATEMENTS.

FIRST MEETING: 1956.

THE FIRST ACTUAL LUNCHEON MEETING WAS HELD IN CINCINNATI IN 1956. BEFORE THIS MEETING "E. K." ARRANGED WITH "HUTCH" TO HAVE THE LUNCHEON SHOWN IN THE PRELIMINARY PROGRAM AND IN THE OFFICIAL PROGRAM. "HUTCH" ALSO GOT OUT LETTERS TO ALL LIFE MEMBERS ADVISING THEM OF THE LUNCHEON. THE LETTER TALKED ABOUT NOTHING BUT "A LUNCHEON" -- "A GET-TO-GETHER" -- FOR THE "OLD CLINKERS".

AT THIS 1956 MEETING MR. H. E. SPROULL, LIFE MEMBER, WAS CHOSEN AS THE HOST CHAIRMAN AND HE MADE SEVERAL ANNOUNCEMENTS OF THE MEETING WITH THE RESULT THAT 16 MEMBERS WERE PRESENT. THEY WERE ALL ENTHUSIASTIC ABOUT THE LUNCHEON, BUT IT WAS NOT CONSIDERED NECESSARY TO HAVE A FORMAL ORGANIZATION AND NO PLAN OF OPERATION WAS DRAWN UP. IT WAS, HOWEVER, AGREED TO MEET FOR ANOTHER LUNCHEON IN CHICAGO DURING THE 1957 WINTER MEETING OF THE SOCIETY.

IT WAS DECIDED TO AGAIN SELECT A LOCAL LIFE MEMBER AS THE HOST CHAIRMAN. MR. E. P. HECKEL OF CHICAGO WAS CHOSEN AS THE INCOMING HOST CHAIRMAN FOR THE CHICAGO MEETING.

AT THE CINCINNATTI MEETING (1956) "E. K." POINTED OUT THAT THE CONSTITUTION OF THE SOCIETY PROHIBITED A SUBDIVISION SUCH AS THE LIFE MEMBERS CLUB FROM COLLECTING ANY DUES. WITHOUT DUES THE CLUB HAD NO FUNDS AND COULD NOT CREATE ANY WORTHWHILE ACTIVITY. SEVERAL MEMBERS THOUGHT THAT THE CLUB SHOULD HAVE AT LEAST ONE OBJECTIVE. MR. A. C. BUENSOD OF NEW YORK STATED THAT IF THEY COULD NOT HAVE DUES THAT THERE WAS NO REASON WHY THE CLUB COULD NOT ACCEPT DONATIONS. "BUEY" BECAME VERY ENTHUSIASTIC AND STARTED OUT ON HIS OWN INITIATIVE TO COLLECT DONATIONS. HE POINTED OUT TO THE LIFE MEMBERS THAT THEY DID NOT PAY ANY DUES TO THE SOCIETY AND THAT IF THEY WANTED TO MAKE A VOLUNTARY DONATION OF THE SAME AMOUNT OR LESS TO THE CLUB THAT IT WOULD BE LEGAL AND THAT COUNCIL COULD NOT OBJECT. "BUEY" RAISED \$150.00 AT THIS FIRST MEETING AND IT WAS TURNED OVER TO MR. H. E. SPROULL FOR SAFE KEEPING UNTIL THE CLUB COULD DECIDE ON A PROGRAM.

AFTER THE CINCINNATTI MEETING "E. K." DISCUSSED POSSIBLE WORTH WHILE PROGRAMS WITH SEVERAL MEMBERS AND A VARIETY OF PROJECTS WERE CONSIDERED. ONE SUGGESTION WAS MADE BY MR. ROBERT W. ROOSE THAT THE CLUB MAKE AN AWARD TO SOME DESERVING PROFESSOR, OFFERING HIM ENCOURAGEMENT TO TEACH SUBJECTS OF OUR PROFESSION AND INDUSTRY, AND TO PROMOTE INTEREST AMONG HIS STUDENTS TO STUDY THESE SUBJECTS.

SECOND MEETING: 1957.

THE SECOND LUNCHEON MEETING WAS HELD IN CHICAGO WITH MR. E. P. HECKELL AS HOST CHAIRMAN. AT THIS MEETING IT WAS DECIDED THAT THE CLUB SHOULD HAVE A PERMANENT SECRETARY-TREASURER AND MR. HECKELL NOMINATED MR. E. K. CAMPBELL WHO WAS ELECTED ON A UNANIMOUS VOTE. IT WAS ALSO DECIDED THAT THE HOST CHAIRMAN BE SELECTED IN ADVANCE FOR THE NEXT MEETING AND THAT HE WOULD AUTOMATICALLY BECOME A MEMBER OF THE EXECUTIVE COMMITTEE OF THE CLUB AND REMAIN ON THE EXECUTIVE COMMITTEE FOR ONE (1) YEAR AFTER HE HAD SERVED

AS HOST CHAIRMAN. THE EXECUTIVE COMMITTEE WAS THUS COMPOSED OF THE PERMANENT SECRETARY AND TWO (2) HOST CHAIRMAN, ONE (1) OF WHICH DROPPED OUT AND ONE (1) NEW ONE WAS APPOINTED EACH YEAR. THE EXECUTIVE COMMITTEE WOULD SELECT THE RECIPIENT OF THE AWARD OF MERIT. "E. K." COMMENTED THAT THIS ORGANIZATION WAS "SIMPLE ENOUGH -- NOT CUMBERSON".

IT WAS FELT THAT NO FURTHER ORGANIZATION WAS NECESSARY AT THAT TIME AND THAT THE BASIC FORM OF THE ORGANIZATION WOULD CONTINUE UNTIL IT WAS OTHERWISE CHANGED BY THE MEMBERSHIP.

IT WAS ALSO AGREED THAT "E. K." WOULD MAKE THE NECESSARY LUNCHEON ARRANGEMENTS, HANDLE ANY AFFAIRS THAT CAME UP DURING THE YEAR, AND APPOINT AN INCOMING HOST CHAIRMAN FOR EACH LUNCHEON.

IT WAS ESTABLISHED AT THIS MEETING THAT MR. ROOSE'S SUGGESTION BE FOLLOWED AND THAT THE EXECUTIVE COMMITTEE WOULD MAKE THE SELECTION AND THAT THE FIRST AWARD WOULD BE MADE AT THE PITTSBURG MEETING. ADDITIONAL DONATIONS WERE MADE AT THIS MEETING TO FINANCE THE EXPENSES OF THE AWARD OF MERIT. MR. SPROULL ALSO TURNED OVER TO MR. CAMPBELL ALL OF THE MONEY WHICH HAD BEEN DONATED AT THE CINCINNATI MEETING.

MR. RALPH STRANGER WAS SELECTED AS THE HOST CHAIRMAN FOR THE PITTSBURG MEETING AND CONSEQUENTLY BECAME A MEMBER OF THE EXECUTIVE COMMITTEE FOR THE NEXT TWO YEARS.

DURING THE YEAR 1957 THE EXECUTIVE COMMITTEE CONSISTING OF E. K. CAMPBELL, E. P. HECKELL, AND RALPH STRANGER SELECTED PROFESSOR LYNN HELANDER FOR THE FIRST AWARD OF MERIT.

THIRD MEETING: 1958.

THE THIRD LUNCHEON WAS HELD IN PITTSBURG WITH MR. RALPH STRANGER AS HOST CHAIRMAN. THERE WAS CONSIDERABLE DISCUSSION ABOUT THE AWARD OF MERIT AND THE NUMBER OF AWARDS WHICH SHOULD BE MADE EACH YEAR. THE A.S.H.A.E. COUNCIL RECOMMENDED THAT THE CLUB LIMIT THE NUMBER TO ONE (1) AWARD PER YEAR AND REQUESTED THAT THE CLUB'S SELECTION OF AN Awardee BE APPROVED BY THE COMMITTEE ON HONORS AND AWARDS. PROFESSOR HELANDER HAD BEEN APPROVED UNANIMOUSLY PRIOR TO THE LUNCHEON.

AT THIS MEETING MR. H. BERKLEY HEDGES WAS SELECTED AS THE HOST CHAIRMAN FOR THE PHILADELPHIA MEETING.

AT THE BANQUET IN PITTSBURG MR. E. K. CAMPBELL WAS INTRODUCED AS THE PERMANENT SECRETARY OF THE LIFE MEMBERS CLUB AND MADE THE FIRST "AWARD OF MERIT" TO PROFESSOR LYNN HELANDER OF KANSAS STATE COLLEGE.

FOURTH MEETING: 1959.

THE FOURTH LUNCHEON MEETING WAS HELD IN PHILADELPHIA WITH MR. H. BERKLEY HEDGES AS HOST CHAIRMAN, AND THE FOLLOWING MEMBERS PRESENT;

DURING THIS MEETING IT WAS FOUND THAT MR. REG. F. TAYLOR WAS THE ONLY LIFE MEMBER IN THE STATE OF TEXAS. ALTHOUGH HE WAS FROM HOUSTON HE AGREED TO SERVE AS HOST CHAIRMAN FOR THE DALLAS MEETING.

DURING THE BANQUET AT PHILADELPHIA ALL LIFE MEMBERS WERE ASKED TO STAND. AN ACCURATE COUNT WAS NOT MADE BUT THERE APPEARED TO BE MORE THAN 60 PRESENT. FOLLOWING THIS MR. E. K. CAMPBELL WAS INTRODUCED AND MADE THE SECOND ANNUAL AWARD OF MERIT TO PROFESSOR MERL BAKER OF THE UNIVERSITY OF KENTUCKY, RESEARCH FOUNDATION, LEXINGTON, KENTUCKY.

DURING THE SUMMER THE EXECUTIVE COMMITTEE CONSISTING OF E. K. CAMPBELL, H. BERKLY HEDGES, AND REG. F. TAYLOR SELECTED PROFESSOR L. S. O'BANNON FOR THE 1960 AWARD AND HE WAS UNANIMOUSLY APPROVED BY THE COMMITTEE ON HONORS AND AWARDS.

FIFTH MEETING: 1960.

THE FIFTH LUNCHEON MEETING WAS HELD AT DALLAS, BECAUSE MR. TAYLOR WAS UNABLE TO ATTEND THE MEETING MR. A. F. BARNES OF HOUSTON ACTED AS HOST CHAIRMAN FOR MR. TAYLOR. MR. BARNES HAD BECOME A LIFE MEMBER JUST PRIOR

TO THE MEETING, THUS MAKING TWO (2) LIFE MEMBERS IN TEXAS. THOSE PRESENT WERE AS FOLLOWS;

MR. BARNES INTRODUCED MR. E. K. CAMPBELL WHO PROPOSED THAT CERTAIN STAFF MEMBERS FROM THE NEW YORK OFFICE BE MADE HONORARY MEMBERS IN RECOGNITION OF THEIR LONG AND FAITHFUL SERVICE TO THE SOCIETY. THOSE NOMINATED AND UNANIMOUSLY ELECTED WERE MR. A. V. HUTCHINSON, FORMER EXECUTIVE SECRETARY, MISS DOROTHY MILDNER, AND MISS ANNE O'NEIL. MR. CAMPBELL ANNOUNCED THAT MR. WALLACE HAD BEEN A MEMBER OF THE SOCIETY FOR 31 YEARS BUT WAS SHORT TWO (2) YEARS OF REACHING THE AGE OF 65. HE WAS THEN INDUCTED INTO THE CLUB AS AN HONORARY MEMBER.

THERE WAS CONSIDERABLE DISCUSSION BECAUSE COUNCIL HAD SUGGESTED THAT THE CLUB CHANGE ITS NAME TO SENIOR MEMBERS CLUB BECAUSE THE NEW A.S.H.R.A.E. BY-LAWS APPEARED TO REQUIRE AN ADDITIONAL QUALIFICATION OF "--THE RENDERING OF DISTINGUISHED SERVICE TO THE SOCIETY". THE MEMBERS PRESENT OBJECTED TO THE CHANGE IN NAME AND APPOINTED A COMMITTEE, WITH E. K. CAMPBELL AS CHAIRMAN, TO FOLLOW UP THE MATTER OF THE NAME OF THE CLUB WITH THE BOARD OF DIRECTORS OF THE SOCIETY. THIS MATTER WAS RESOLVED BY A CHANGE IN THE BY-LAWS, WHICH ELIMINATED "DISTINGUISHED SERVICE" AND MADE THE ATTAINMENT OF LIFE MEMBER AUTOMATIC INSTEAD OF REQUIRING ACTION BY THE HONORS AND AWARDS COMMITTEE. THE ACTION WAS TAKEN BY THE A.S.H.R.A.E. BOARD OF DIRECTORS ON JUNE 12, 1960 AND THE OFFICIAL AMENDMENT TO THE BY-LAWS WAS APPROVED IN JUNE, 1961.

THE MATTER OF A PROPOSED AWARD OF MERIT TO BE PRESENTED AT THE VANCOUVER SUMMER MEETING WAS DISCUSSED AT SOME LENGTH. NO FINAL ACTION WAS TAKEN AT THE MEETING, BUT THE EXECUTIVE COMMITTEE (LMC) LATER DECIDED AGAINST MAKING AN AWARD AT THE SUMMER MEETING. NO HOST CHAIRMAN FOR THE CHICAGO MEETING WAS ELECTED AT THE MEETING, BUT LATER THE EXECUTIVE COMMITTEE APPOINTED MR. SAMUEL R. LEWIS.

DURING THE BANQUET MR. E. K. CAMPBELL PRESENTED THE **THIRD** AWARD OF MERIT TO PROFESSOR LESTER S. O'BANNON, OF TEXAS A & M COLLEGE, COLLEGE STATION, TEXAS.

SIXTH MEETING: 1961. SEE ADDENDUM No 1, PAGE 10

THE SIXTH LUNCHEON MEETING WAS HELD AT CHICAGO WITH MR. SAMUEL R. LEWIS AS HOST CHAIRMAN. AT THIS MEETING THE SUBJECT OF CLUB FUNDS WAS DISCUSSED AND THE MEMBERS WERE REMINDED THAT NO DUES COULD BE COLLECTED. IT WAS AGAIN SUGGESTED THAT ANY LIFE MEMBER COULD MAKE A DONATION TO THE CLUB BY SENDING IT TO MR. E. K. CAMPBELL WHO HAD ALSO BEEN ELECTED AS TREASURER. THE MEMBERS PRESENT WERE ADVISED THAT IF HALF OF THOSE PRESENT DONATED \$25.00 OR POSSIBLE A LITTLE LESS THAT THE CLUB WOULD HAVE SUFFICIENT FUNDS TO PURCHASE THE BRONZE PLAQUE AND PROVIDE THE HONORARIUM OF \$100.00 OR \$150.00. MR. CAMPBELL ADVISED THAT WHEN THE TREASURY GOT LOW HE WOULD ADVISE THE CLUB MEMBERS AND THAT THEY COULD DONATE AS THEY SAW FIT.

MR. WALTER A. GRANT, PRESIDENT OF A.S.H.R.A.E. HAD REQUESTED MR. CAMPBELL TO SUGGEST A MEMORIAL TO MR. A. V. HUTCHINSON WHO HAD RECENTLY DIED. AT THE CHICAGO MEETING THE LIFE MEMBERS CLUB WAS AUTHORIZED TO PREPARE THE MEMORIAL IN THE FORM OF A PICTURE TO BE PRESENTED TO THE SOCIETY.

FOURTH

DURING THE CHICAGO BANQUET THE AWARD OF MERIT WAS PRESENTED TO DEAN BURGESS H. JENNINGS, OF NORTHWESTERN UNIVERSITY, TECHNICAL INSTITUTE, EVANSTON, ILLINOIS.

SEVENTH MEETING: 1962.

THE SEVENTH ANNUAL LUNCHEON MEETING WAS HELD IN ST. LOUIS WITH MR. EVERETT E. CARLSON PRESIDING AS HOST CHAIRMAN. PROFESSOR JOHN W. GOFF HAD BEEN SELECTED TO RECEIVE THE AWARD, HOWEVER, HE REFUSED TO ACCEPT IT AND NO AWARD WAS MADE. AT THIS MEETING COLONEL CROSBY FIELD WAS SELECTED AS HOST CHAIRMAN FOR THE NEW YORK MEETING. THE AWARDEE FOR NEW YORK WAS NOT SELECTED DURING THIS MEETING BUT THE EXECUTIVE COMMITTEE SELECTED PROFESSOR M. K. FAHNSTOCK DURING THE FALL OF 1962.

THE MEMORIAL TO MR. A. V. HUTCHINSON CONSISTING OF A PLAQUE WITH HIS PHOTOGRAPH ETCHED IN BRONZE WAS PRESENTED TO THE SOCIETY AFTER THE BANQUET BY MR. E. K. CAMPBELL ON BEHALF OF THE LIFE MEMBERS CLUB. THIS PLAQUE NOW HANGS IN THE NEW YORK OFFICE.

THIS WAS THE LAST MEETING ATTENDED BY "E. K.". HIS DEATH ON NOVEMBER 25, 1962 WAS A GREAT LOSS TO THE CLUB AND TO THE SOCIETY. THE LOSS OF THE PERMANENT SECRETARY LEFT ONLY TWO (2) MEMBERS ON THE EXECUTIVE COMMITTEE, MR. E. E. CARLSON AND COLONEL CROSBY FIELD.

ADDENDUM NO. 3: 1963 (AFTER THE SUMMER MEETING).
